I have received unfair treatment from my immediate supervisors and co-workers, and verbal harassment regarding my work ability and personal sex life. I have been repeatedly threatened with discharge. Discrimination in the form of inequal scrutiny, counseled or reprimand towards me and not equally to the men workers pertaining to the same items of the routine
