CONSULTATION REPORT

29 yr old divorced Airman 1st class was referred for psych. evaluation by Dr. [unclear]. No background material available. Pat. had previous psych. evaluation. Comes here for treatment of muscle spasms in the neck & occipital. Attractive verbal, female felt that exam. was not upsetting. Does not require any treatment in her own opinion. gave extensive history of difficulty in adjustment while in military service. sexual purpose. Was allegedly raped on 3 separate occasions. Gross physical and sexual abuse which she allegedly suffered at hand of men at the base - substituted occasions in June 77. Still feels harassed but is "able to talk back" - less happy since she also dislikes her. Supposedly was threatened with discharge because of her behavior "criticizing behavior" - but decided to stay in military "because I have 5 dependents: 3 children + sister and her child".

Relevant, coherent, - admitted to moderate use of barbiturates, valium and alcohol - function combined - some confusion - not states in past - apparently related to abuse of drugs and alcohol. Vet. maintain however that she did not "imagine" - but she really was "abducted" in her room "now faces of intruders".

Affect - no pathology. Perseveration - clear memory intact. May 2 Personality disorder
